Photo needs to be submitted in .jpg or .tiff electronic format to the Ferndale Chamber of Commerce and supplied on a CD or submitted electronically thru email. Watermarks, signatures, copyright symbols will not be allowed on photos. Photo credit will be clearly displayed with each winning photo.

RULES:

- 1) Open to everybody
- 2) Photo must be of Ferndale area
- 3) Submitted in .jpg or .tiff format
- 4) Entry form with each entry
- 5) One photo per entry
